Declaration of physical fitness (Solo Pilots & visiting Instructors)

Health and Safety Brief – IF UNSURE, ASK

AGC(A) has an obligation under the HSW Act to ensure that, so far as is reasonably practical, contractors and visitors do not come to harm. All visitors to the club have a legal duty to take care and to avoid harming others by their actions. Therefore, please observe the following guidelines:

1. **By signing this form**, I confirm that I am fit to fly. If I am solo pilot, I also confirm that I possess one of the following valid documents: CAA Personal Medical Declaration (PMD) or a CAA LAPL Medical Certificate or a CAA Class 1 or Class 2 Medical Certificate (or equivalent).
2. This is an active airfield. Gliders, aeroplanes, helicopters or other aircraft may approach, land or take-off in any direction, so please comply with any instructions given to you by club members or military personnel. If in doubt, ask for clarification from the Duty Instructor, Launch Point Marshall or club member.
3. It is very likely that your personal and motor insurances will not provide cover while on the airfield. You may, therefore, be personally liable and may be sued in connection with any accident which you may cause.
4. Stay in the specified areas. If unsure, ask. Do not walk in front of gliders, aeroplanes, helicopters or aircraft.
5. If unsure, please ask a club member to accompany you in crossing any part of the airfield.
6. Keep a good lookout above, to the front, side and behind you. Give way to gliders, aeroplanes, helicopters or other aircraft at all times when driving or walking on the airfield.
7. **Control of your children.** You are responsible for their actions. Do not touch gliders, aeroplanes or helicopters, other aircraft, launch equipment, machinery or cables unless instructed to do so.
8. Do not enter the airfield manoeuvring area unless you are sure you are authorised to do so.
9. Beware of hidden cables moving at high speed between the launch area and the launching machinery.
10. By signing this form, all Temporary members confirm that they have considered whether personal, medical and / or income protection insurance is appropriate for them. **This type of insurance is not provided by AGC(A).**
11. By signing this form, I confirm that I will comply with the Flying Order Book (FOB) as well as the Club's Risk Assessments (RAs), where relevant.
